SECTION 4: First aid measures

4.1 Description of first-aid measures

- Advice on protection against fire and explosion : cumstances they should wear a compressed air-fed respirator during the spraying process and until such time as the particulates and solvent vapour concentration has fallen below the exposure limits.
The workplace should be equipped with an emergency shower and eye-rinsing facility.
