SECTION 4: First aid measures

4.1 Description of first-aid measures

Do not return residues to the storage containers. Smoking, eating and drinking are forbidden in application area. For personal protection see section 8. Comply with the health and safety at work laws.

When operators, whether spraying or not, have to work inside the spray booth, ventilation is unlikely to be sufficient to control particulates and solvent vapour in all cases. In such circumstances they should wear a compressed air-fed respirator during the spraying process and until such time as the particulates and solvent vapour concentration has fallen below the exposure limits.

The workplace should be equipped with an emergency shower and eye-rinsing facility.

Avoid contact with the skin, eyes and clothing.

Handle in accordance with good industrial hygiene and safety practice.

Do not breathe vapors or spray mist.

Advice on protection against fire and explosion : Avoid all sources of ignition: heat, sparks, open flame.
