SECTION 4: First aid measures

4.1 Description of first-aid measures

- General advice : In case of intoxication, call a poison control center or physician for treatment advice, taking the packaging or the label of the product.

Advice on protection against fire and explosion : Handle in accordance with good industrial hygiene and safety practice.
